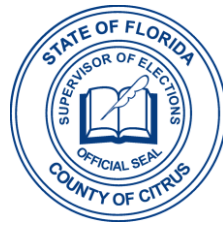

## 2018 CANDIDATE QUALIFYING FEES

### 2018 ELECTION DATES:

Candidates for the offices listed below qualify and file their campaign reports with the Citrus County Supervisor of Elections. **Florida law requires that all candidates must file an *Appointment of Treasurer and Designation of Depository* before collecting or spending any money on behalf of their campaign.**

#### COUNTY COMMISSION (Partisan)

**Term:** 4 Years

**Qualifying Fee:** **\$3,5XX.XX Major Party** (6% of annual salary of \$58,9XX) \*  
**\$2,3XX.XX Minor Party** (4% of annual salary of \$58,9XX) \*

**Petition Signatures:** 1057

**District 2** (Ronald Kitchen incumbent)

**District 4** (Scott Carnahan incumbent)

**Requirements:** Residency requirement: Per F.S. 100.041 a candidate must reside in the County Commission District from which he/she seeks to be elected on the date that the county canvassing board certifies the results of the election pursuant to F.S. 102.151.

#### SCHOOL BOARD (Non-Partisan)

**Term:** 4 Years

**Qualifying Fee:** **\$1,3XX.XX** (4% of annual salary of \$33,4XX)\*

**Petition Signatures:** 1057

**District 1** (Thomas Kennedy incumbent)

**District 3** (Doug Dodd incumbent)

**District 5** (Linda Powers incumbent)

**Requirements:** Residency requirement: Must reside in the School Board District at time of qualifying.

#### HOMOSASSA SPECIAL WATER DISTRICT (Non-Partisan)

**Term:** 4 Years

**Qualifying Fee:** \$25.00

**Petition Signatures:** 25 (F.S. 99.095(b))

**Seat 2** (Caitlin Wilcox incumbent)

**Seat 4** (Winston C. Perry incumbent)

**MOSQUITO CONTROL BOARD (Non-Partisan)**

**Term:** 4 Years  
**Qualifying Fee:** \$25.00  
**Petition Signatures:** 25 (F.S. 99.095(b))  
Seat 1 (Albert Jordan incumbent)  
Seat 3 (Brenda Buzby incumbent)

**CITRUS COUNTY COMMUNITY CHARITABLE FOUNDATION, INC. (Non-Partisan)**

**Term:** 4 Years  
**Qualifying Fee:** \$25.00  
**Petition Signatures:** 25 (F.S. 99.095(b))  
Seat 2 (Sondra Moylan incumbent)

**Qualifying for County elections begins Noon, June 18, 2018 and ends Noon, June 22, 2018.**

You may declare your candidacy at any time prior to these dates, but you must file your *Appointment Of Campaign Treasurer and Designation of Depository before* you collect or spend any money.

**Florida law provides two methods for qualifying for a county office:**

**1) Payment of the qualifying fee during the week of qualifying.**

**2) Petition to qualify by the Alternative Method.**

Petitioning is done by collecting the specified number of signatures.

Candidates must submit petitions for verification to Supervisor of Elections.

As provided by law the Supervisor of Elections shall be paid in advance the sum of **\$105.70**, 10 cents for each signature checked. **(Paid by Campaign check only)**

**Deadline for submitting petitions for verification is prior to noon, May 23, 2016 – County Candidates**
