CITRUS COUNTY SPECIAL LIBRARY DISTRICT ORDINANCE NO. 84-01

An ordinance of Citrus County, Florida, providing for the establishment of the Citrus County Special Library District; providing for definitions; providing for the establishment of the Citrus County Special Library District pursuant to the authority of section 125.01 (5) (a-c), Florida Statutes; providing for the boundaries of said Special Library District; providing for the powers of the governing body; providing for the levy of an ad valorem tax not to exceed one-third (1/3) mill to be used for Library purposes; providing for an annual budget; providing for disposition of proceeds; providing for the collection and administration of ad valorem taxes collected within the boundaries of the district; providing for reimbursement to County Officials who provide administrative assistance to said taxing district; providing for a construction clause; providing for severability; providing for the approval of the ad valorem tax levy and creation of the Citrus County Special Library District by referendum; and providing an effective date.
