Qualifying for County elections begins Noon, June 8, 2020 and ends Noon, June 12, 2020.

You may declare your candidacy at any time prior to these dates, but <u>you must file your</u> <u>Appointment of Campaign Treasurer and Designation of Depository **before** you collect or <u>spend any money</u>.</u>

Florida law provides two methods for qualifying for a county office:

- 1. Payment of the qualifying fee during the week of qualifying.
- 2. Petition to qualify by the Alternative Method.

Petitioning is done by collecting the specified number of signatures. Candidates must submit petitions for verification to Supervisor of Elections.

As provided by law the Supervisor of Elections <u>shall be paid in advance</u> the sum of **\$109.40**, 10 cents for each signature checked. **(Paid by Campaign check only)**

Deadline for submitting petitions for verification is prior to noon, May 11, 2020.
