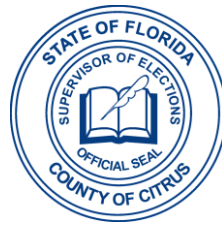

**Requirements:** Residency requirement: Per F.S. 100.041 a candidate must reside in the County Commission District from which he/she seeks to be elected on the date that the county canvassing board certifies the results of the election pursuant to F.S. 102.151.

**Requirements:** Residency requirement: Must reside in the School Board District at time of qualifying.

**Term:** 4 Years

**MOSQUITO CONTROL BOARD (Non-Partisan)**

**Term:** 4 Years  
**Qualifying Fee:** \$25.00  
**Petition Signatures:** 25 (F.S. 99.095(b))  
Seat 2 (Leon McClellan incumbent)

**CITRUS COUNTY COMMUNITY CHARITABLE FOUNDATION, INC. (Non-Partisan)**

**Term:** Seat 1 – 4 Years  
Seat 2 – 2 Years  
**Qualifying Fee:** \$25.00  
**Petition Signatures:** 25 (F.S. 99.095(b))

**Qualifying for County Judge election begins Noon, May 2, 2016 and ends Noon, May 6, 2016.**

**Qualifying for County elections begins Noon, June 20, 2016 and ends Noon, June 24, 2016.**

You may declare your candidacy at any time prior to these dates, but you must file your *Appointment Of Campaign Treasurer and Designation of Depository* before you collect or spend any money.

**Florida law provides two methods for qualifying for a county office:**

**1) Payment of the qualifying fee during the week of qualifying.**

**2) Petition to qualify by the Alternative Method.**

Petitioning is done by collecting the specified number of signatures.

Candidates must submit petitions for verification to Supervisor of Elections.

As provided by law the Supervisor of Elections shall be paid in advance the sum of \$97.40, 10 cents for each signature checked. **(Paid by Campaign check only)**

**Deadline for submitting petitions for verification is prior to noon, April 4, 2016 – County Judge**

**Deadline for submitting petitions for verification is prior to noon, May 23, 2016 – County Candidates**
