Spring is here! What this means besides budding flowers, longer days and sneezes, is that elections are right around the corner!

We are pleased to inform everyone that we have received tested and trained on the new equipment. We are confident it will be a smooth roll out to voters and are about using the new system in the upcoming Primary Election on August 28<sup>th</sup> and the General Election on November 6<sup>th</sup>.

The Florida Legislature has completed the 2018 session. In the world of elections, an important bill was passed enabling Florida to become a member of ERIC (Electronic Registration Information Center). ERIC is a multistate partnership that uses a sophisticated and secure data-matching tool to improve the accuracy and efficiency of state voter registration systems. Florida will join 22 states and the District of Columbia in participating in the program that was established in 2012. These reports will be a valuable for the elections office to maintain accurate voter registration rolls on a continuous basis.

A March mailing of Vote-by-mail request forms were sent to all Citrus county registered voters. The current voter information on file is on the form and can be verified by the voter. If you have any questions contact the office.

### How Does Someone Use RegisterToVoteFlorida.gov?

- The website can be used in two ways: To submit an online voter registration application to register to vote or to update a registration record, or
- To prefill a voter registration application form that you can print, sign, and deliver to your county Supervisor of Elections.

The site can be accessed using standard internet browsers, including Internet Explorer, Firefox and Chrome. The site is compatible with mobile devices.

The website is ADA compliant, includes accessibility features for person with disabilities, and is available in English and Spanish.
