

RESOLUTION NO. 88 - 125

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF CITRUS COUNTY, FLORIDA, PLACING ON THE NOVEMBER GENERAL ELECTION BALLOT THE QUESTION OF WHETHER THE CITRUS COUNTY SOLID WASTE COLLECTION, DISPOSAL AND ASSESSMENT ORDINANCE WHICH PROVIDES FOR MANDATORY COLLECTION AND DISPOSAL OF SOLID WASTE GENERATED WITHIN CITRUS COUNTY, AND WHICH PROVIDES FOR THE LEVY OF AN ASSESSMENT FOR THE COLLECTION AND DISPOSAL OF SOLID WASTE GENERATED BY RESIDENTIAL PROPERTY WITHIN CITRUS COUNTY SHOULD BECOME EFFECTIVE.

WHEREAS, the Board of County Commissioners on June 14, 1988 held a public hearing with respect to the adoption of Citrus County Ordinance No. 88-09, known and cited as the Citrus County Solid Waste Collection, Disposal and Assessment Ordinance, and

WHEREAS, a public notice of said public hearing was published in the Citrus County Chronicle in accordance with general law, and

WHEREAS, the Board of County Commissioners received public testimony and comment at said public hearing and at the conclusion of said public hearing adopted Citrus County Ordinance No. 88-09, and

WHEREAS, Section 39 of Citrus County Ordinance No. 88-09 states that the Ordinance shall not take effect until approval by a majority of the voters in the election to be held coinciding with the next general or special election to be held in Citrus County;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Citrus County, Florida, in regular meeting this 26th day of July, 1988, as follows:

1. The Board does hereby direct the Citrus County Supervisor of Elections to place on the General Election Ballot, to be held November 8, 1988, the following question:

"Shall the Citrus County Solid Waste Collection, Disposal and Assessment Ordinance, which provides for mandatory collection and disposal of solid waste generated within Citrus County and which provides for the levy of an assessment for the collection and disposal of solid waste generated by residential property within Citrus County, become effective?"

2. The Clerk of the Board is hereby directed to forward a certified copy of this Resolution to the Citrus County Supervisor of Elections.

3. This Resolution was adopted by a majority of all members of the Board of County Commissioners.

4. The Clerk of the Board is hereby directed to advertise notice of this Referendum by publication of this Resolution on October 4, 1988 and October 18, 1988 in the Citrus County Chronicle.
