

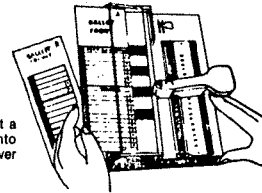

INSTRUCTIONS TO VOTE

STEP 2

Move the chrome punch so that the red pointer is right of the candidate's choice. Depress the button which will punch out the + in the voting square right of the candidate's name. To vote on any proposition appearing on the ballot, PUNCH OUT THE CROSS + in the voting square to the right of the words "FOR" or "AGAINST".



STEP 1

Vote only one ballot card at a time. Slip ballot all the way into tray, UNDER clear plastic cover from left side of machine.

To vote for a write-in candidate, write name in space provided.

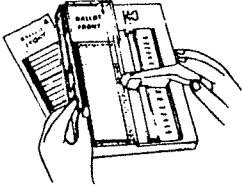

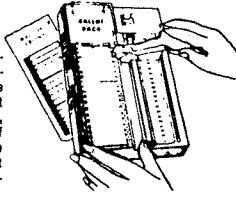

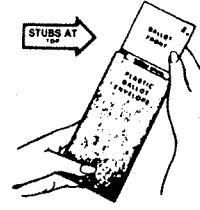
STEP 3

Repeat Step 2 with each remaining ballot card. All distinguishing marks or erasures are forbidden and make the ballot void. If you make a mistake, tear or deface any portion of your ballot card, replace the card in the plastic ballot envelope and return to the election official for another ballot.



STEP 4

After you have completed voting, return the punch head to the top position. Place your ballot card(s) in the plastic envelope with the numbered stub(s) at the top and hand it to the election official, who shall then in the presence of the voter, remove the numbered stub(s). The voter may then personally deposit the voted ballot(s) in the ballot box or direct the election official to do so in the voter's presence.

Proposing an amendment to the State Constitution, effective upon adoption, to authorize the Legislature to provide for issuance by the state, without a vote of the electors, of bonds pledging the full faith and credit of the state, the proceeds of which are to be used to finance or refinance the cost of acquiring real property for state roads or for constructing bridges.

NO. 5 ARTICLE VII, SECTION 3 Property Tax Exemption for Widowers. Proposing an amendment to the State Constitution to extend the property tax exemption for widows to widowers as well.

NO. 6 ARTICLE II, SECTION 5 ARTICLE XI, SECTIONS 2, 5 and 6 Taxation and Budget Reform Commission. Transfers authority to review matters relating to state and local taxation and the budgetary process from the Constitution Revision Commission to a newly created Taxation and Budget Reform Commission to be established in 1990 and every 10 years thereafter. The new commission will issue a report and it may propose statutory changes to the Legislature, and submit proposed constitutional changes to the voters.

Amendment provides that a person entitled to recover damages for bodily injuries in any action may not recover more than \$100,000 for non-economic losses; defines non-economic losses to include pain and suffering, inconvenience, mental anguish, loss of capacity to enjoy life, loss of consortium and other non-pecuniary losses; provides by general law the maximum amount recoverable may be adjusted utilizing a consumer price index published by the United States Government; provides an effective date.
